Executive Summary

- A total of 666 surveys were completed with both users and non users regarding current usage and future development of Bute Park.
- A third (33.8%) of respondents reported that they used Bute Park more than once a week whilst over half (56.5%) use it more than once a month.
- Two-thirds (66.1%) of respondents reported that they visits Bute Park for 'walking' and more that a third (37.8%) to 'sit and relax'.
- Approximately half (47.9%) of respondents were aware of the restoration project.
- More than two-fifths (43.3%) of respondents felt that the appearance of Bute Park had improved over the past twelve months. Specific improvements that were identified included: the Summer House (46.8%), Access to the park (15.6%), tidiness of the park (11.3%) and paths (11.3%).
- Just 11.0% of respondents felt that Bute Park had declined in the past twelve months. Of these the main complaints were the new roads that had been constructed in the park (50.7%), removal of trees (30.1%), increased traffic (17.8%) and building work (15.1%).
- The provision of formal floral displays, grounds maintenance and the work of the rangers were rated highest by respondents to the consultation. The provision of toilets, lighting, car parking and publicity were all rated poorest.
- High levels of approval were expressed towards the Summer House café which was typically described as "A fantastic addition to the park and a great place to meet with friends".
- Respondents most wanted an education and training centre to provide information both on the history of Bute Park and also the nature and environment within.
- Cardiff Castle was associated with Bute Park by 94.1% of respondents, the animal wall by 70.4% and Coopers Field by 69.1%.
- The thing that people reported to like most about the Bute Park was its city centre location. Many considered Cardiff to be almost unique to other large cities in having such and expansive 'green lung' in the heart of the city that provides an escape from the 'hustle and bustle' of urban living.
- Personal safety was identified by a minority of respondents as the worst thing about Bute Park. Some felt the perception of poor safely to be exacerbated both by the lack of a visible presence of security/park wardens and poor lighting in the area. Additionally concern was also expressed with regard to the possible over commercialisation of the Park from ongoing developments.
- Overall the consultation revealed a huge level affection and protectiveness from respondents for Bute Park. The majority were passionate about its value as a public space and whilst many were supportive of plans to develop the location there was also a demand that this be done sympathetically to preserve the area for future generations.

Background

Bute Park is generally considered as one of the jewels in Cardiff's crown. It is unique and filled with internationally recognised historic, horticultural and environmental features. Cardiff Council is keen to ensure that the experience for park users continues to improve and that the area remains accessible and relevant to all. The Council's aim is to deliver a national people's park for the Capital City - a flagship for Wales and the UK.

To aid this objective Bute Park is currently undergoing a £5.6 million restoration project, supported by a £3.1 million grant from the Heritage Lottery Fund. This is to restore some important historic features within the park as well as providing some new facilities. Work is expected within the park until 2013. To ensure that the ongoing work that is undertaken meets the requirements and priorities of park users it was essential that the Council heard their views and experiences.

Methodology

Cardiff Research Centre (CRC) along with officers in Park Services devised a schedule of research that will include bi-annular public consultation throughout the redevelopment period. The methodology was designed to include a mixture of face to face interviews with park users and electronic surveys which were distributed via social network sites including Facebook and Twitter.

The questionnaire itself was based on an earlier survey undertaken in 2004 which questioned city wide park users about their views on Bute Park. The 2004 consultation gathered a total of one hundred face to face interviews as well as a total of 796 additional returns via post and email. References to the 2004 report are made within this document where comparable data is available.

Reporting

Within sections of the questionnaire respondents were asked to rate a series of statements that relate to Bute Park on a scale of one to five with one being "strongly disagree" and five being "strongly agree".

For the purpose of analysis and reporting these ratings have been adapted to produce a score which provides an indication to the level of success that is prevalent in relation to each service function. The scoring classification that is used within this report is shown below:

Scale Classification¹

4.25 – 5.00	This is an excellent score – retain status quo
3.75 – 4.24	This is a very good score – with some limited room for further improvement
3.25 – 3.74	This is a good score – but a clear plan for improvement is needed
3.00 – 3.24	This is a fair score – there is considerable room for improvement
2.75 – 2.99	this is a poor score – a high degree of dissatisfaction exists
1.00 - 2.74	This is a very poor score – urgent attention is needed

In addition a traffic light system has been adopted to highlight areas of good practice and indicate where future work needs to be focused.

N.B. figures in tables do not always equal the total number of responses to the survey due non-response to some questions.


Results

In total, CRC consulted with 666 individuals. Face to face interviews were conducted on site in Bute Park with 143 park users whilst 523 people shared their views via an electronic survey.

1. On average how frequently do you use Bute Park?

A third (33.8%) of respondents reported that they used Bute Park more than once a week whilst over half (56.5%) use it more than one a month.

2. How do you usually visit Bute Park?


Half (48.5%) of respondents reported visiting the park alone whilst a similar proportion also visited Bute Park with a partner.

3. What are your reasons for visiting Bute Park?

Two-thirds (66.1%) of respondents reported that they visit Bute Park for 'walking'. More than a third (37.8%) liked to use the park as a place to sit and relax whilst a similar proportion (32.6%) also used the park as a short cut.

The activities of walking, relaxing and taking a short cut also accounted for three of the top four reasons given for using Bute Park during the 2004 park consultation². During this consultation the proportion of respondents reporting to participate in each of the activities was lower (walking - 45.4%, sit and relax - 23.4%, short cut 19.7%).

² Responses from postal/electronic surveys only. Amongst face to face respondents the proportion reporting to use the part to sit and relax rose to 92.2% although all interviews took place during the summer months.

4. Bute Park is currently undergoing a £5.6 million restoration project, supported by a £3.1 million grant from the Heritage Lottery Fund. This is to restore some important historic features within the park as well as providing some new facilities. Are you aware of this project?

Approximately half (47.9%) of respondents overall were aware of the restoration project although the percentage was considerably higher amongst those responding online (51.8%) compared to those users interviewed face to face (33.1%).

5. Do you feel that the park has changed in appearance over the past twelve months?

More than two-fifths (43.3%) of respondents felt that the appearance of Bute Park had improved over the past twelve months. A further fifth (21.3%) felt that the park had remained the same whilst a quarter (25.8%) remained unsure.

When this question was asked in 2004 just 14.6% of respondents considered the park to have improved over the previous twelve months whilst four fifths (80.6%) considered it to have stayed the same.

6. In what way do you feel that it has improved or declined?

Of those respondents believing Bute Park to have improved over the past twelve months almost half (46.8%) made specific reference to the new Summer House Café.

7. On a rating scale of 1 to 5 with 1 being 'poor' and 5 being 'excellent' how would you rate the provision of the following services in Bute Park?

Overall respondents awarded the highest score to the formal floral displays within the park. With a score of 4.17 this can be considered a very good score – with some limited room for further improvement.

The lowest overall score was given to toilet facilities within the park, although this was shown to be a far greater issue for those completing the questionnaire electronically than for those interviewed face to face.


8. The new Summerhouse Kiosk building was completed as part of the restoration bid and was inspired by the original Bute Park Summerhouse which used to stand in the grounds. The new facility opened to the public in May 2010 and provides hot and cold refreshments, public toilets and outdoor seating. On a rating scale of 1 to 5 with 1 being 'poor' and 5 being 'excellent' how would you rate the Summerhouse against the following?

The Summerhouse Kiosk received high scores against each of the attributes questioned. Respondent were however most satisfied with the location and attractiveness of the new building. Respondents questioned face to face also responded more favourable than those completing the questionnaire electronically. Many of those interviewed face to face had had an opportunity to gain first hand knowledge of the facilities and amongst this group the scores received for all of the attributes were between 4.25 – 5.00 indicating an excellent score and a need to retain the status quo.






A total of 138 respondents provided additional comments in relation to the development of a training and education centre. Those shown below provide a representative sample of respondents' views.

13. Please let us know if there are other activities that you would like to see developed within Bute Park.

A total of 103 respondents made suggestions as what 'other' activities they would like to see in the park. Many of the suggestions were variations of those already covered in the consultation i.e. guided walks, horticultural classes and historical talks. A selection of respondents were keen that further adaptations be made to the area to provide facilities specifically for young children whilst other hoped to optimise the area for a variety of sporting activities e.g. running, cycling, Frisbee or exercise stations.

Most frequently however within this section respondents took the opportunity to express there desire not to see Bute Park over developed to cater for a range of activities. Comments made here included:

"We are in danger of over-commercialising the park and having 'tour groups' may be too invasive for people who can appreciate/study the plants/relax with family on own time."

"I have had a thought come to me that I really would like it to just be Bute Park, lovely with maybe the facility to get a coffee etc. I am not sure that I want to see change and commercialisation and over use of this well loved place. Something's are lovely as they are and should be just maintained not changed."

"You run the risk of destroying what is left of the park by over suburbanising it, a less is more approach is what's needed. People already enjoy the park in their own way - jogging, pushing prams, strolling, sitting on benches enjoying the sun, dog walking, playing games, there is no need for formality and structure."

"Please don't turn the Park into a 'theme park', as it needs to remain as an informal, natural part of the city and not be over-developed!"

"The park should be an undisturbed area. Please avoid attracting crowds. The environment and the wildlife will not be helped by increased use by lots of people."

14. Which of the following do you associate with Bute Park?

Cardiff Castle was by far the aspect most associated with Bute Park with 94.1% of respondents recognising this as such. Also associated with the park by a high proportion of respondents was the animal wall (70.4%) Coopers Field (69.1%) and firework displays³ (62.5%).

15. What do you think is the best thing about Bute Park?

A total of 599 respondents went on to provide information about the things they like best about Bute Park.

By far the thing that people reported to like most about the park was its city centre location. Many considered Cardiff to be almost unique to other large cities in having such and expansive 'green lung' in the heart of the city that provides an escape from the 'hustle and bustle' of urban living.

Just a few of the comments provided include:

That is in the middle of the city yet feels like you are away from it all

It is a green space in the heart of the city where the traffic noise is dulled from its usual roar and replaced with peace. It is simply a beautiful place to be surrounded by history yet in the middle of a City. A wonderful place to relax and stroll.

It's location. I love that it's so close to the city, that it has big green fields and the Taff. It's so nice to walk through it and end up very close to the City Centre!

It is an oasis of quiet in the city centre.


The pure joy of having a wonderful park land running right through the centre of the City....it MUST be preserved at all costs

When I'm walking around Bute Park I feel like I'm in the middle of the country and I'm a stone's throw away from the City Centre!

Also a popular feature of the park was its sheer size. Respondents to the survey appreciated the fact that the park was of such a size that it provides a 'sense of freedom' to its users. The space available ensures that that the area never feels overcrowded, and "you're never on top of other visitors no matter how busy it is". This means that everyone is able to "find a spot for various activities" whilst the park is still able to provide a wide variety of features including: flower beds, riverside walks, trees and informal areas.

One respondent summed up the feelings of many in stating: "I feel lucky to have access to such a green area in the middle of the city. I love the variety of environments that such a large park can provide."




16. What do you think is the worst thing about Bute Park?

A total of 510 people responded to this question, of which 15.1% took the opportunity to state that they considered Bute Park to be without failings. Of those individuals that were able to highlight specific areas for improvement issues relating to personal safety featured highly with ten separate references made to recent muggings that had occurred in the park land. Some felt the perception of poor safely to be exacerbated both by the lack of a visible presence of security/park wardens and poor lighting in the area.

Significant concern was also expressed with regard to the possible over commercialisation of the park from ongoing developments (7.6%), too many events (4.3%) and increased traffic (2.7%) all identified as the worst things about Bute Park.

17. Is there anything you wish to add that this survey has not allowed you to say regarding Bute Park?

A total of 169 respondents took the opportunity to add comments. In the majority of instances this reiterated a variety of the comments already covered within the questionnaire i.e. opening hours, lighting, safety etc.

Forty-one (24.3%) of the comments made referred directly to the proposed development plans arising from the National Heritage Fund Grant. These comments came from a mixture of those both in favour and vehemently against further development of the area. Fundamentally however the major opinion was that any development work was to take place it must by sympathetic to the existing environment and ensure that the park is preserved for future generations. A selection of the comments received included:

"I am appalled by the bit-by-bit erosion of the Bute Parks since 1945, and would like a halt to be called to this. The Park should not be seen as a way of making money, and should not be commercialised. Its role as a wonderful facility for the people of Cardiff to enjoy should be respected."

"A park is a constantly changing thing that needs to keep up with modern usage, not a museum. An exhibition showing the change of the park over the centuries would be really interesting, and would help to put it into the context of the rest of the city. Keep up the good work!"

"Thanks to Lord Bute, Cardiff has a fantastic park and castle in the heart of our city. Please will the Council stop eroding parkland and overdeveloping Bute Park, trees that have taken hundreds of years to grow can not easily be replaced. Please save the park from being over commercialised and let us hand on our legacy intact to future generations."

"Good luck with the project!"

"It's a shame that the Council decided to steamroller the building of the new access points completely disregarding the views of the majority of park users. The false claims that the plans were supported by bodies such as the Victorian Society are an absolute scandal."

"I am delighted that so much is being invested in the park."







The proportion of respondents interested in becoming further involved in consultation and the management of Bute Park is almost exactly the same as those levels recorded in 2004. At this time 17.1% of respondents expressed and interest in joining a 'friends group' whilst 13.4% were prepared to be involved in a future focus group about the future of the park.
